We remained a steadfast financial pillar for our members and we continue to take that responsibility very seriously.

Our vision for SDCCU continues to be focused on exceeding the needs and expectations of our members, serving the community as a primary financial partner, and providing sound financial services any where, any way and at any time. By most measures, we ended the year in a stronger position than we started. In 2023, our credit union remained fiscally strong, growing to over \$13 billion in assets and welcoming even more members to SDCCU by prioritizing breakthrough banking products and services.

● PRESIDENT'S REPORT

● With 2023 behind us, I'd like to reflect on what an unprecedented year it has been for the financial services industry. For more than 85 years, SDCCU has been focused on meeting the financial needs of those who work and live in the areas we serve throughout Southern California. We take pride in providing competitive products and free financial education to help our members achieve their financial goals. SDCCU's Board and management focus on prudent and conservative practices to ensure the credit union remains financially sound for years to come.

With the continued talk of financial headwinds demonstrated through high inflationary pressures throughout 2023, remaining a steadfast pillar for our local communities was a top priority. To ease the residual financial strain affecting individuals throughout Southern California, management placed a concentrated effort on highlighting our products and services that offer a financial giveback to members. Since 2020, SDCCU has proudly returned more than \$3.1 million to SDCCU Cash Rewards VISA® holders, saved our members more than \$2.7 million in closing costs with select home loan purchases, helped our members earn more than 2 billion Fly Miles Plus® rewards, saved members who use a convenient CO-OP ATM more than \$12.3 million in out-of-network surcharge fees and re-introduced our 'Bump Up Certificate' program for members hedging that rates may go up, and want the peace of mind provided by an insured instrument to place their hard-earned funds for safe keeping.

Numerous improvements were also made to our online banking platform to provide a more convenient and intuitive experience for members to manage their accounts. New security enhancements were introduced to further protect our robust online systems. We also launched a refreshed sdccu.com with improved functionality to make navigating and accessing credit union information easier.

SDCCU was excited to resume our in-person support of many local non-profits through our participation in hundreds of community events in an effort to improve the communities where we live and work. We also developed new partnerships and campaigns to further enhance our

efforts. With ongoing offerings of financial education and resources, we proudly delivered over 150 free presentations to nearly 3,200 attendees as part of the commitment we have to improving the financial future of individuals through our financial wellness initiatives.

Our dedication to providing exceptional service once again garnered a positive response from members, industry and peers as SDCCU was acknowledged with several awards and accolades. In 2023, the credit union received awards recognizing our service and commitment to the community including: the *San Diego Business Journal* Cybersecurity Awareness Initiative of the Year Award, and the 21st Annual American Business Award for Community Engagement through our SDCCU Stuff the Bus program which raised more than \$103,000 to purchase school supplies for students experiencing homelessness throughout San Diego County. SDCCU was also recognized as a Top Five Best-in-State Credit Union by *Forbes*, and finally, SDCCU was proudly voted San Diego's BEST Credit Union for the 24th year in a row in The San Diego's BEST *Union-Tribune* Readers Poll. Of course, we couldn't have done it without the support of members like you. From all of us at SDCCU, thank you!

In 2024, SDCCU will remain committed to being your trusted financial partner and community leader by offering exceptional products and services to our members and continuing our support in the communities where we live and work.

COMMUNITY IMPACT

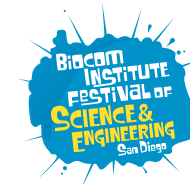


SDCCU is an engaged community partner and proud to support non-profit organizations throughout Southern California. Our partnerships with these philanthropies allow us to help shape the lives of those in our communities through volunteerism, financial support and public awareness.

We are proud to continue to positively impact the community by providing support for many local non-profits, events and activities throughout Southern California. We are also very proud to have our SDCCU Stuff the Bus campaign honored with a Gold Stevie Award for Communications/PR Campaign of the Year - Community Engagement, as well as the *San Diego Business Journal's* Cybersecurity Awareness Initiative of the Year Award for our efforts to raise cybersecurity awareness and provide free resources to the community through financial education.

- Sponsored the iHeart Rady Children's Giveathon which raised **\$483,972**

● FINANCIAL WELLNESS WEDNESDAYS

- As an engaged community partner, Financial Wellness Wednesdays is one of many community efforts and activities SDCCU spearheads annually throughout Southern California. Our organization is committed to helping teachers, parents and students make educated financial decisions. SDCCU is engaged in several philanthropic efforts aimed at improving overall economic well-being and making a positive impact in our community and local schools.

Every year, from January to March, SDCCU partners with the San Diego County Library System in support of the *Live Well San Diego* initiative to host Financial Wellness Wednesdays presentations on a variety of topics aimed at improving financial health. In 2023, we continued the Financial Wellness Wednesdays program virtually. This format allowed us to easily reach members of our community to share this valuable financial education.

SDCCU CLASSROOM HEROES

SDCCU proudly honored San Diego County teachers through SDCCU Classroom Heroes, launched in partnership with the San Diego County Office of Education. Through our partnership, we recognized three local Classroom Heroes quarterly. Winning teachers were featured on SDCCU social media platforms and received a \$250 Visa® gift card. SDCCU STUFF THE BUS

In partnership with the San Diego County Office of Education and iHeartMedia San Diego radio stations, SDCCU Stuff the Bus was held to help the more than 20,000 students experiencing homelessness in the county. The school supply drive was again held online and community members were also able to donate in-branch and at any Jersey Mike's® location throughout San Diego County.

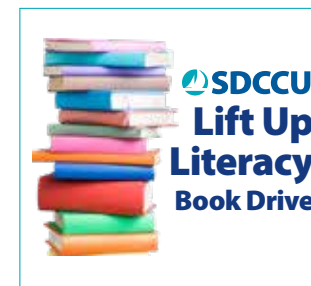

OC MARATHON

SDCCU was proud to be the title sponsor of the 2023 SDCCU OC Marathon and Half Marathon, considered one of the best marathons in California with its diverse terrain and majestic ocean views. More than 20,000 runners and 30,000 spectators attended the weekend of events on May 6 & 7 at the OC Fair and Event Center.

As one of the country's top financial institutions, many have asked us why we chose to be the title sponsor of the SDCCU OC Marathon — a big event primarily focused on physical health. The answer is simple. Research shows that poor financial health can often lead to diminished physical health, which means encouraging and maintaining good financial health among individuals in our communities is essential to fostering a healthy and thriving economy.



LIFT UP LITERACY

SDCCU was excited to partner with the San Diego County Library (SDCL) to host its inaugural Lift Up Literacy book drive campaign aimed at promoting literacy throughout San Diego County. Throughout October, new and gently used books were collected at all of San Diego County's convenient SDCCU branch locations throughout San Diego County.

In total 11,058 books were collected and donated to support SDCL initiatives dedicated to increasing reading throughout the county. SDCL encourages a love of reading in every way across its 33 branches, five kiosks, and Free Little Libraries, an honor-based book exchange program encased in welcoming mailbox-like structures. These are placed in areas managing literacy challenges, including transportation, financial or technical barriers.

● 2023 IN REVIEW

- In 2023, SDCCU employees leaned into our *Feel the Teal* culture by providing exceptional service to our more than 436,000 members. Our team worked tirelessly to enhance SDCCU product and service offerings to better serve the needs of our members.

INTERNET BRANCH UPGRADES

In 2023, SDCCU delivered enhancements that created a more intuitive experience for members to manage their accounts. SDCCU implemented additional security enhancements to easily detect, prevent and protect members and the credit union from potential attacks to SDCCU systems. Members who utilize third-party apps for account aggregation saw improvements in authentication of their SDCCU accounts.

Tool tips were added within online banking to aid new users when registering for online and mobile banking for various account types (business, consumer, trust, etc.) An updated version of the ATM/Branch locator interface was deployed, which included a default display of SDCCU branches and deposit-taking ATMs. A popup window was introduced to online and mobile banking to display important announcements to members.

WEBSITE UPGRADES

The sdccu.com website was given a fresh new look in May of 2023 that came fully loaded with improvements to the experience and enhancements with security, allowing for a more efficient web experience. The 'Make an Appointment' feature, which allows members to make appointments for a variety of credit union services, was added back to the website in February and generated 4,606 appointments for the year!

In 2023, SDCCU was proud to deliver exceptional benefits to our valued members, along with breakthrough banking products and services, low fees, competitive rates on deposits, low rates on loans and generous member givebacks.

- Nearly **\$866,465** back in the hands of members who use our SDCCU Cash Rewards Visa Platinum – more than **\$8.1 million** since the start of the program in 2011
- **679 million miles** earned through the SDCCU Visa Platinum with Fly Miles Plus®
- Our members saved approximately **\$5.7 million** in out-of-network ATM fees using our surcharge-free CO-OP ATMSM network
- Exclusive member discounts and savings available in Internet Branch online and mobile banking including the addition of FunEx and Love My Credit Union® Rewards partnerships with notable discounts to Southern California theme parks

● TREASURER'S REPORT

- SDCCU continued to achieve many milestones in 2023, with membership at over 436,000 and total assets increasing to nearly \$13.5 billion. Return on assets continued to be healthy at 72 basis points for year-end. The credit union remains fiscally strong despite a challenging economy by remaining focused on prudent lending and conservative financial management practices.

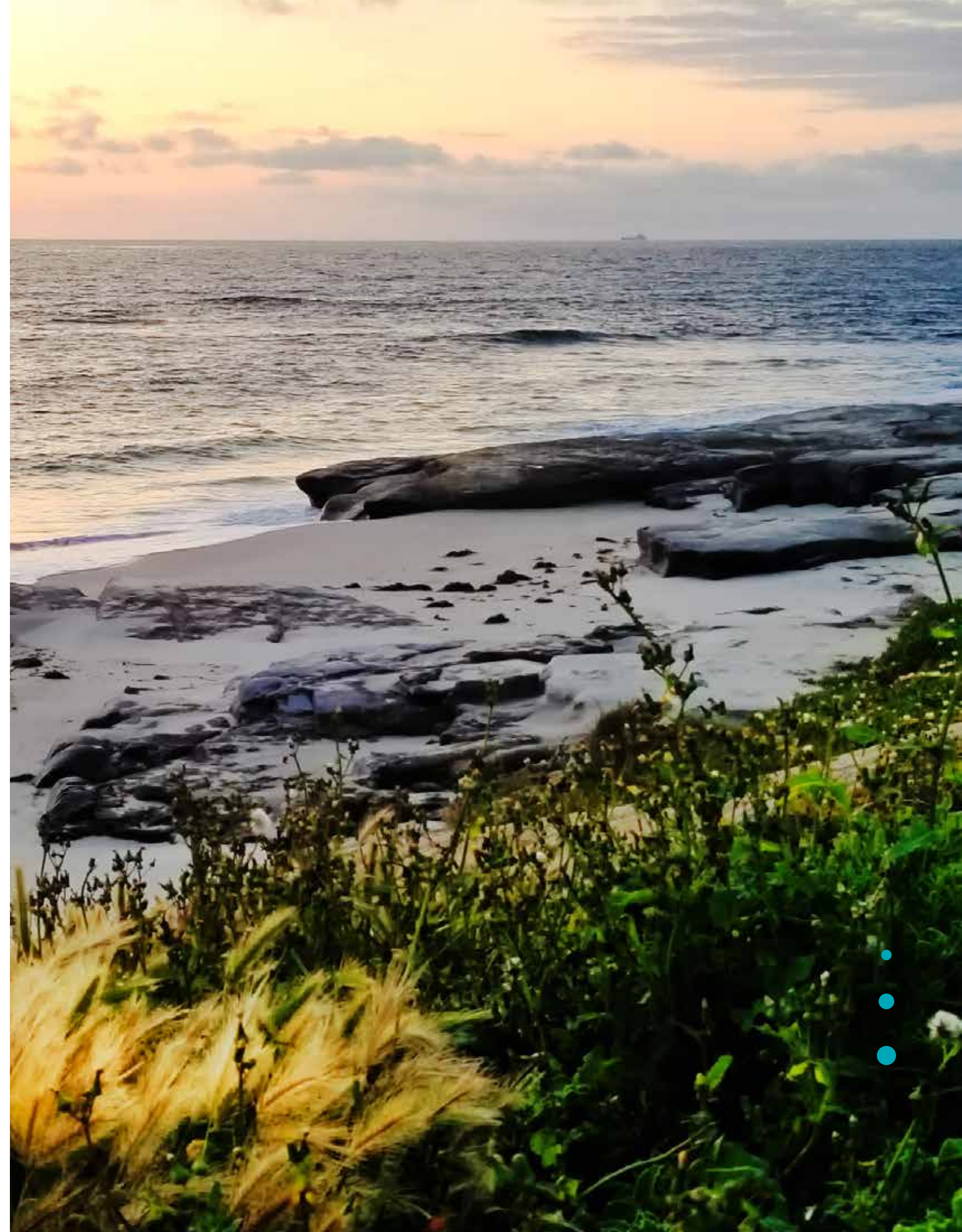
SDCCU's net capital as of December 31, 2023, remains outstanding at nearly 13%. This is well above the 7% minimum capital level for "well capitalized credit unions" as established by the National Credit Union Administration (NCUA). SDCCU's ability to consistently maintain this level of capital is indicative of our financial strength and ability to weather challenging financial periods under the leadership of the SDCCU Board of Directors and management.

Our commitment to remaining financially healthy and providing members with the best financial products and services will help ensure that SDCCU remains San Diego's BEST Credit Union, and one of Southern California's top performing credit unions, for years to come.

The credit union is financially sound and remains well positioned for another successful year.

SUPERVISORY COMMITTEE'S REPORT

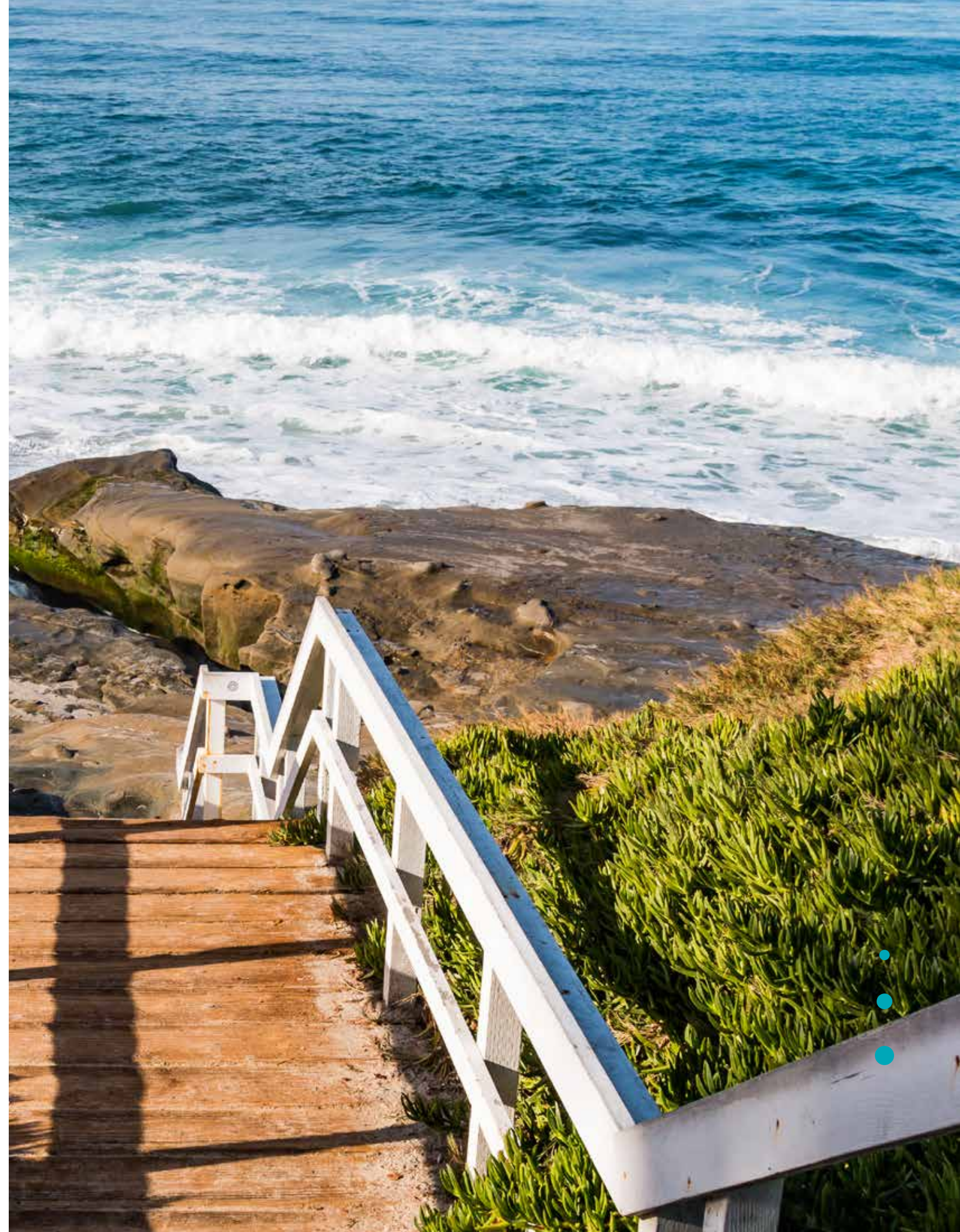
The SDCCU Supervisory Committee is made up of volunteer members who independently evaluate the strength, safety and soundness of SDCCU's operations and activities. The Committee's primary focuses are to ensure that an independent audit is performed annually, the account balances of the membership are verified, adequate policies and procedures exist to protect the credit union's resources, governing regulations and policies and procedures are properly followed and that the financial statements reflect SDCCU's results of operation.

The Supervisory Committee collaborates with internal auditors, the Board of Directors, the President & CEO and employees of SDCCU to ensure that the credit union's assets are safeguarded by upholding policies, procedures and regulatory requirements. The Supervisory Committee retained the services of national CPA firm, RSM US LLP, to perform an audit of SDCCU's financial statements. RSM US LLP's annual audit of SDCCU's financial statements ensures that they represent fairly, in all material respects, the financial position and results of operations of SDCCU in conformity with U.S. Generally Accepted Accounting Principles.

The Supervisory Committee has again determined that SDCCU is a strong financial institution. We thank the Board of Directors, management and staff for their cooperation and commitment to sound financial practices.

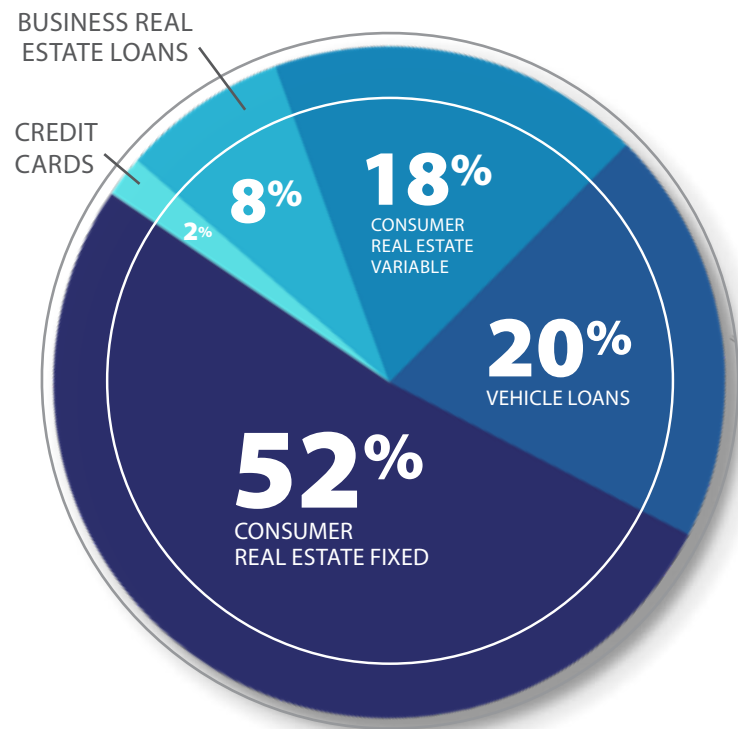
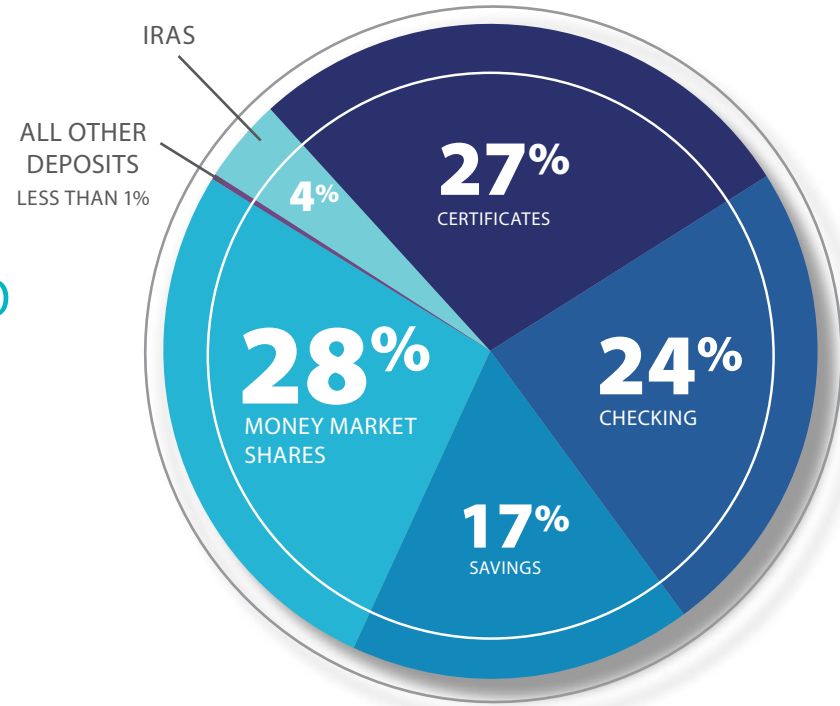

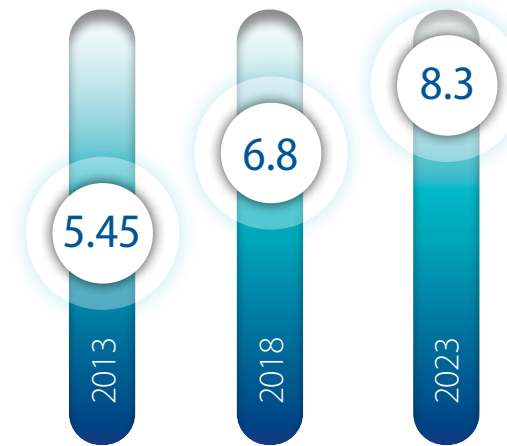

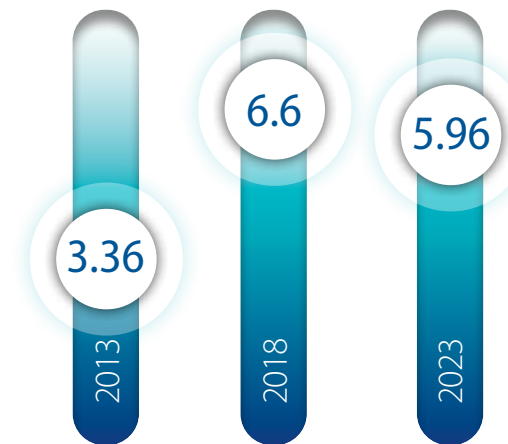
COMPOSITION OF DEPOSIT PORTFOLIO



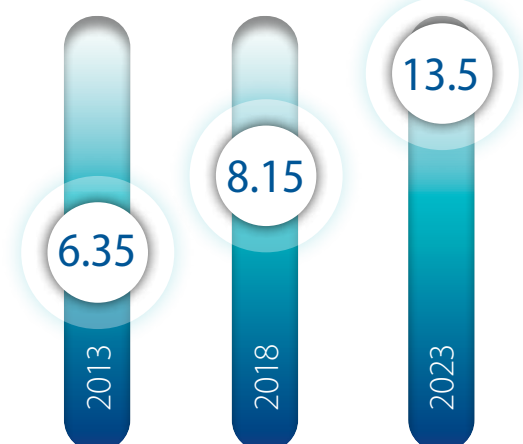
COMPOSITION OF LOAN PORTFOLIO
