



San Diego County Credit Union was formed with the guiding principle of putting people before profits, and I'm pleased to say that over eight decades later, our focus remains the same. SDCCU is proud to keep our members, community and employees at the forefront of every decision we make as we strive to make a positive impact in the lives of our members and communities we serve. In 2024, we remained committed to excellence by continuing to make banking easier and more convenient and providing exceptional member service to collectively deliver an overall improved member experience.

We were pleased to make numerous improvements to our website and online banking platform in 2024, as well as continue to offer generous financial givebacks to members. In an effort to provide a better member experience, enhancements were made to our mobile deposit service allowing for improved imaging capturing. Across our online banking platform and sdccu.com, we worked to maintain efficient and secure experiences to protect our members' data. Our members also had the opportunity to take advantage of the products and services that help put money back in their wallets. This past year, SDCCU returned more than \$1 million to SDCCU Cash Rewards VISA® holders, helped our members earn more than 310 million fly miles and saved members who use convenient CO-OP Network ATMs more than \$10 million in out-of-network surcharge fees.

In 2024, SDCCU continued its focus on improving the communities where we operate. We did this in part through our ongoing support of many local non-profits, including numerous new partners, and our participation in hundreds of community events. We also remained committed to improving the financial future of individuals by offering financial education and resources—delivering nearly 180 presentations to 3,760 members of our community. As one of Southern California's top credit unions,

San Diego's largest locally-owned financial institution, and a Live Well San Diego partner, SDCCU is committed to helping the community make educated financial decisions by delivering financial education, products and services.

We are also proud to have been acknowledged for our dedicated community support and efforts to improve lives with several awards and accolades. In 2024, SDCCU's commitment to corporate social responsibility was acknowledged with American Business Awards and Hermes Creative Awards for our SDCCU Stuff the Bus program, which raised more than \$111,000 to purchase school supplies to help send students experiencing homelessness in San Diego back to school, ready to learn like their peers. In addition, our Lift Up Literacy program provided more than 10,000 books to support San Diego County Library's local literacy efforts. SDCCU's commitment to educating the community about cybersecurity earned us *San Diego Business Journal's* Cybersecurity Stewardship Award for the second consecutive year. SDCCU was also proudly voted San Diego's BEST Credit Union for a milestone 25th year in a row in *The San Diego Union-Tribune* Readers Poll. 


#### **SDCCU STUFF THE BUS**

In partnership with the San Diego County Office of Education and iHeartMedia San Diego radio stations, SDCCU Stuff the Bus helped the more than 21,000 students experiencing homelessness throughout the county. The school supply drive was again held online and community members were also able to donate in-branch and at any Jersey Mike's® location throughout San Diego County.



- 8,909 backpacks filled with nearly 216,000 school supplies donated
- 30 school districts and 31 charter schools in San Diego
   County benefited from supplies
- Donations totaled over \$16,674 in Orange and Riverside counties to help provide supplies to students in need in those communities. SDCCU Stuff the Bus supported students in those counties though our partnership with the Angels Baseball Foundation.



#### **LIFT UP LITERACY**

SDCCU was excited to partner with the San Diego County Library (SDCL) to host its second annual Lift Up Literacy book drive campaign aimed at promoting literacy throughout San Diego County. Throughout October, new and like-new books were collected at all of SDCCU's San Diego County locations.

In total, 10,269 books were collected and donated to support SDCL initiatives dedicated to increasing reading throughout the county. SDCL encourages a love of reading in every way across its 33 branches, five kiosks and Little Free Libraries, an honor-based book exchange program encased in welcoming mailbox-like structures. These are placed in areas facing literacy challenges, including transportation, financial or technical barriers.

## **2024 IN REVIEW**

In 2024, SDCCU employees leaned into our *Feel the Teal* culture by providing exceptional service to nearly 428,000 members. Our team worked tirelessly to enhance SDCCU's products and services to better serve the needs of our members.

#### **INTERNET BRANCH UPGRADES**

In 2024, SDCCU made several improvements to online banking for members. Mobile deposit service improvements included an enhanced new platform for improved deposit image capture to SDCCU accounts.

Security enhancements were made to further detect, prevent and protect members and the credit union from nefarious traffic to online banking with additional security policies in place to block unwanted traffic worldwide. Multi-Factor Authentication (MFA) friction settings were also updated to improve the member experience by challenging online banking logins at appropriate frequencies.

A new Estate Planning module within the online banking desktop platform was launched. Members are now able to create customized wills and trusts through SDCCU's partner, Legal Karma.

- Our members saved more than **\$10 million** in out-of-network ATM fees using our surcharge-free CO-OP ATM<sup>5M</sup> network

## **TREASURER'S REPORT**

2024 was a steadfast and successful year for SDCCU, as we continued to serve as a strong financial partner to our members and surrounding communities. SDCCU ended the year with total assets at nearly \$9.2 billion and return on assets continued to be healthy at 58 basis points for the year. Net capital at nearly \$1.8 billion as of December 31, 2024 was 19.47%, which is nearly three times the 7% minimum capital level for "well capitalized credit unions" as established by the National Credit Union Administration (NCUA). The credit union remains fiscally strong and is focused on prudent lending and conservative financial management practices.

SDCCU's ability to consistently maintain high capital levels is indicative of our demonstrated financial strength and ability to weather financial cycles under the leadership of the Board of Directors and management. Our commitment to better banking means that the Board of Directors is devoted to making smart financial decisions to ensure the credit union remains San Diego's BEST Credit Union for years to come. Looking forward, the credit union will continue to invest time and resources appropriately and efficiently to provide members increased convenience along with some of the best financial products and services.

The credit union is financially sound and well positioned for another successful year in 2025.

## **SUPERVISORY COMMITTEE'S REPORT**


The Supervisory Committee is made up of volunteer members who independently evaluate the strength, safety and soundness of the credit union's operations and activities. The Committee's primary focuses are to ensure that an independent financial audit is performed annually, the account balances of the membership are verified, adequate policies and procedures exist to protect the credit union's resources, governing regulations, policies and procedures are properly followed and that the financial statements reflect SDCCU's results of operation.

The Supervisory Committee collaborates with internal auditors, the Board of Directors, the President & CEO and employees of SDCCU to ensure that the credit union's assets are safeguarded by upholding policies, procedures and regulatory requirements. The Supervisory Committee retained the services of a large national audit firm, to perform an audit of SDCCU's financial statements. The annual audit ensures the financial statements present fairly, in all material respects, the financial position and results of operations in conformity with U.S. Generally Accepted Accounting Principles.




